 - > The <u>Certificate of Completion</u> issued by the client or <u>official receipt(s)</u> for the SLCC should be stamped and signed as "Certified True Copy of the Original" by the duly authorized representative of the bidder.
- II. Section VIII. Bidding Forms Annex A Detailed Financial Bid Form
 - The <u>Minimum Monthly Rate</u> of each personnel as provided in Annex A Detailed Financial Bid Form is the minimum monthly basic salary that shall be paid to every personnel.
- III. Checklist of Eligibility, Technical and Financial Components
 - The checklist of eligibility, technical and financial components is provided herein as ANNEX A.

- ➤ The Deadline for Submission of Eligibility Requirements and Bids shall be on September 11, 2018, at 1:00 p.m. (7th Floor NDC Clock), at the 7th Floor, NDC Building, 116 Tordesillas St., Salcedo Village, Makati City.

- Valid PhilGEPS Certificate of Registration of Membership under Platinum category (Platinum Membership).
- 2. "Annex A" of the Certificate of PhilGEPS Registration (Platinum Membership).
- Statement of All On-Going Government and Private Contracts, including contracts awarded but not yet started, if any, whether similar or not similar in nature and complexity to the contract to be bid. (Using the prescribed format in Section VIII. Bidding Forms of Bidding Documents p. 99)
- 4. Statement of Single Largest Completed Contract (SLCC) similar to the contract to be bid, within the past three (3) years prior to the date of submission and receipt of bids, the value of which must be equivalent to at least fifty percent (50%) of the ABC. (Using the prescribed format in Section VIII. Bidding Forms of Bidding Documents p. 100)
- 5. Attachment of the Statement of SLCC:
 - 5.1 Certified true copy of Certificate of Completion issued by the client for the SLCC;

- 5.2 Certified true copy of official receipt(s) issued to the company for the SLCC
- 6. The Bidder shall submit the following:
 - 6.1 NFCC computation in accordance with ITB Clause 5.5; and
 - 6.2 2017 Audited Financial Statements, showing, among others, the bidder's total and current assets and liabilities stamped "received" by the Bureau of Internal Revenue (BIR) or its duly accredited and authorized institutions;

or

6.3 A committed Line of Credit from a Universal or Commercial Bank which must be at least equal to ten percent (10%) of the ABC to be bid or Eight Hundred Ten Thousand Five Hundred Pesos (₽810,500.00). If issued by a foreign universal or commercial bank, it shall be confirmed or authenticated by a local universal or commercial bank.

Class "B" Documents:

- 7. The Bidder shall submit if applicable:
 - 7.1 Valid Joint Venture Agreement (JVA), in case the joint venture is already in existence;

- 7.2 In the absence of a JVA, duly notarized statements from all the potential joint venture partners, stating that they will enter into and abide by the provisions of the JVA in the event that the bid is successful. Failure to enter into a joint venture in the event of a contract award shall be ground for the forfeiture of the bid security.
 - 7.2.1 <u>Each partner</u> of the joint venture shall submit their respective <u>PhilGEPS Certificate of Registration</u> (<u>Platinum Membership</u>) in accordance with Section 8.5.2 of the IRR of RA 9184. The submission of technical and financial eligibility documents by any of the joint venture partners constitute compliance: Provided, that the partner responsible to submit the NFCC shall likewise submit the Statement of all its ongoing contracts and Audited Financial Statements.
