Please be advised of the following Clarifications in the Bidding Documents raised during the Pre-Bid Conference held on August 15, 2018:

A. SITE/OCULAR INSPECTION

The conduct of site/ocular inspection has been extended until 4:00 p.m. of August 15, 2018. As indicated in the Bidding Documents (Section III. Bid Data Sheet, ITB Clause 6.4 and Section IX. Checklist of Eligibility, Technical and Financial Components, Class "A" Documents a.iv), *"The Bidder should attach Certificate of Inspection issued by the Head of the General Services of the Board of Investments (BOI)."*

B. DESIGNATED AREA FOR DISPOSAL OF DEBRIS

- A portion of I&I Building is allotted for hauling and disposal of debris to be coordinated with the General Services of BOI c/o Mr. Jerry Pajarillo. Hauling of debris shall be done outside the perimeter of the building.

C. BARRACKS/STORAGE FACILITY

- A barracks is allowed for storage facility purposes but not to be used to house workers. A designated area for storage facility is located at the top (Roof Deck) of the I&I Building.

D. DELIVERY OF MATERIALS

- For delivery of materials, a gate pass should be secured and coordinated with the General Services of BOI c/o Mr. Jerry Pajarillo.

E. WATER/POWER SUPPLY

- The water and power supply will be sourced from the I&I Building.

F. WATERPROOFING WORKS

- The scope of work for waterproofing on slab includes Roof Deck, Machine Rooms and AHU Rooms except Penthouse area of the I&I Building.

G. SCHEDULE OF CHIPPING WORKS

- The schedule for chipping works shall be after office hours and shall be coordinated with the General Services of BOI.

- The Deadline for Submission of Eligibility Requirements and Bids shall be on August 28, 2018, 10:00 a.m. (7th Floor NDC Clock) at the 7th Floor, NDC Building, 116 Tordesillas St., Salcedo Village, Makati City.
