<p>The prospective bidder/s raise a concern regarding on the Clause 5.2 of the Bid Data Sheet appear to impose additional conditions that go beyond the SLCC requirement outlined in the procurement rule.</p> <p>Clause 5.2 of the Bid Data Sheet states that:</p> <p>For this purpose, contracts similar to the Project refer to contracts which have the same major categories of work, which shall be Detailed Engineering Design and Construction of Land Development Works with Sewerage Treatment and Water Supply Facilities.</p> <p>Bidder or JV partner must have had a minimum of 10 years of experience in the field and has at least 50 completed Sewerage Treatment Plant (STP) projects regardless of capacity, location, and type of procuring entity that has passed the General Effluent Standards (GES) by the Department of Environment and Natural Resources' Administrative order 2016-08 and/or 2021-19.</p>	<p>Clause 5.2 of the Bid Data Sheet states that:</p> <p>For this purpose, contracts similar to the Project shall be:</p> <ul style="list-style-type: none">a. For this purpose, contracts similar to the Project refer to contracts which have the same major categories of work, which shall be Detailed Engineering Design and Construction of Land Development Works with Sewerage Treatment and Water Supply Facilities.b. Completed within the past five (5) years prior to the deadline for the submission and receipt of bids.c. With at least one (1) existing contract with a total cost equivalent to at least fifty percent (50%) of the total Approved Budget for this Contract (ABC) or should have completed at least two (2) similar contracts, the aggregate amount of which should be equivalent to at least fifty percent (50%) of the ABC.
